## MASTER OF ARTS – ANTHROPOLOGY ARCHAEOLOGY SPECIALIZATION (Plan II - Exam) For Students Entering AY 2024-25

In addition to departmental requirements, candidates for graduate degrees must fulfill University requirements as described in the "Graduate Education" section of the UCSB General Catalog.

The M.A. in Anthropology, Archaeology Specialization, is viewed as an integral part of preparation for the doctorate; students apply to both programs. Students intending to pursue only an M.A. degree in Archaeology must apply to the Terminal M.A. degree program in North American Archaeology.

Students must complete a minimum of **36.0 units** for the master's degree, 24 of which must be from the graduate series in Anthropology. Students in the M.A./Ph.D. program must first complete all of the M.A. requirements before continuing toward the doctorate. The time-to-degree for the M.A. is two years. These courses must be passed with a grade of B or better, with the exception of the Proseminar Requirements which must be passed satisfactorily.

The comprehensive exam for the Archaeology specialization is administered in Spring quarter of the second year. Students take a written comprehensive examination in the following three areas: (1) topical specialization; (2) analytical theory, method and technique; and (3) regional culture history. In consultation with their advisor and committees, students will prepare a bibliography in Fall quarter of their second year for each area in order to prepare for the exams. Students will have a day for each area exam, which will be between 2000 and 3000 words. After taking the exam, students will meet by the end of Spring quarter with their entire committee to discuss the results. A passing qualifying examination demonstrates competency in the literature relevant to their regional and methodological specialization(s) and the ability to communicate that knowledge effectively.  Exam Scores: Ph.D. Pass (required to continue to the Ph.D.), M.A. Pass (a recommendation of probation to the Graduate Dean), or Fail. Students who fail the exam will have one regular quarter to take it again (for Spring exam, deadline is the end of following Fall quarter), with the maximum possible score for a re-take being Pass. If the deadline is not met, the student will be recommended to the Graduate Dean for academic probation. If a passing score has not been awarded by the deadline at the end of the Spring quarter a year after initial comps, the student will not be awarded the M.A. and will be recommended to the Graduate Dean for dismissal.
